Total Time for Program

Minimum program time is approximately 2 hours. Classroom training requires three-four hours.

Introduction of To Hell and Back IV Project (Please read verbatim to participants)

To Hell and Back IV is an educational initiative designed to educate fire fighters on the dangers in fire smoke, most specifically hydrogen cyanide. This program was developed by experts in the fire service, both volunteer and career, and is directly linked to feedback received from fire fighters who have participated in previous To Hell and Back Programs. In addition, THB IV was created because on every fire there is a risk to fire fighters for LODD from smoke inhalation.
